# Planning and Zoning

---

Staff issued 107 zoning certificates (78 residential and 29 commercial) in the 3rd Quarter. Approvals include new homes, accessory structures, signage, additions, interior/exterior modifications, and Minor PUD Modifications.

Staff performed final inspections on eighteen (18) residential properties and one (1) commercial property for zoning compliance with approved plans.

Staff received 23 formal complaints and investigated all 23 in the 3rd Quarter, resulting in 10 violation notices being issued to property owners. It should be noted that 13 of the formal complaints received were either cleared prior to notices being issued, no zoning violation was found, and/or non-zoning related and could not be addressed by the Planning & Zoning Department.

The Board of Zoning Appeals reviewed one (1) case in the 3rd Quarter, approving a variance to allow a garage addition within the front yard setback of a residential home in the White Pines subdivision.

The Zoning Commission reviewed one (1) case in the 3<sup>rd</sup> Quarter. The request was for the review of a Minor PUD Modification for The District at Deerfield. The Zoning Commission approved the case to allow modified freestanding signage at the corner of Wilkens Boulevard and Parkway Drive.

There was a total of 35 zoning certificates issued to construct new residential dwellings (single-family detached). - Current Staffing is down by four deputies. Hiring and training are in process to fill these positions
- New Speed Signs have been acquired and are currently in use in Loveland Park
- K9 Flex and Deputy Hawthorne are progressing well through training. We anticipate them to be serving the township by mid-November.
- Since January 2024, there have been over 22,000 Calls for Service created for Deerfield Township, with 7,851 of those occurring in Q3
  - Notable Statistics for Q3 2024-
    - Nearly 1,500 proactive Calls for Service dedicated to the extra patrol of traffic violation problem areas within the township
    - Over 600 Traffic Stops for violations

The gear committee that Capt. Butler assembled is scheduled to meet next week to present their findings from an extensive testing process focused on various types of structural firefighting gear. Over the past few months, the committee has rigorously evaluated a range of equipment, prioritizing functionality, safety, and durability. Their thorough assessments have involved practical tests in controlled environments, as well as feedback from firefighters who have used the gear in real-world scenarios.

In this upcoming meeting, the committee will share insights on the performance of the gear, highlighting both strengths and weaknesses observed during testing. The findings aim to inform decisions on gear procurement and standardization, ensuring our firefighters are equipped with the best possible tools for their safety and effectiveness on the job. The data and information gained will be vital for guiding our future investments in firefighting equipment and enhancing overall operational readiness.

## **Fire Equipment:**

As mentioned in the second quarter report, a committee comprising members from all three-unit days was formed, reflecting our "One Team" motto to determine the best SCBA for Deerfield Township. We reached out to SCOTT, MSA, Dräger, and Interspiro to provide demonstrations and facilitate rigorous testing sessions for each of the packs.

After months of evaluations at the joint training tower and integration with DTFR training exercises, it was concluded that Dräger far exceeded all other packs tested. Dräger received unanimous approval, with 100% of participating members expressing their satisfaction with the SCBA. All department members had the opportunity to test the different SCBA and provide feedback.

A letter of recommendation, along with key bullet points, will be delivered to the Chief next week for his overall approval for the 2025 budget. It is worth noting that Interspiro was nearly two months behind the other manufacturers in delivering air packs, and when they finally arrived, they failed to include air bottles. Furthermore, the committee recently learned that Interspiro will no longer provide NFPA-compliant packs in the United States.

## **Training:**

DTFR companies have continued to engage in joint training exercises with our mutual aid partners. Recently, we collaborated with Salem/Morrow and LSF D at Oeder's Lake for static water training. In emergency situations, which often require significant manpower, it is essential that we can rely on our mutual aid partners for support. These joint training sessions not only strengthen our operational capabilities but also foster strong relationships among our departments, ensuring effective collaboration when it matters most.

Companies also participated in the NEFC quarterly burn at the Loveland burn tower. DTFR, Mason, and LSF D are currently coordinating training schedules for next year, which will include a variety of joint training exercises across multiple disciplines. These collaborative efforts aim to enhance our skills and preparedness, ensuring that all departments are well-equipped to respond effectively in any situation.

During the third quarter for 2024, our department responded to 750 emergency medical calls. Noteworthy calls during this time included:

- Rescue 57 and Chief 57 responding mutual aid into Loveland-Symmes on West Main Street for reported structure fire. Units arrived with Loveland Fire Units with a working fire in a single-family dwelling. Rescue 57 Crew and Chief 57 assisted with fire suppression and search of the dwelling. This incident occurred on July 15th.

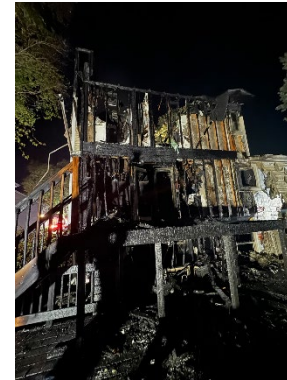
- On the evening of August 5<sup>th</sup>, Rescue 57 and Medic 57 responded to the area Shore Dr. and Locust Rd. for unknown problem. Units arrived on scene to find single MVA involving a motorcycle into pole with male lying on ground. Patient sustain traumatic injuries and was critical at time of incident. Medic 57 transported the patient to Bethesda North Hospital. The patient was later transferred to UC Hospital.
- During the early morning hours on August 21, Ladder 57 and Battalion 56 were requested to respond with Loveland-Symmes Fire Department to Carrington Lane for report apartment fire. On scene with crew encounter heavy fire conditions in a three-story apartment building. The incident went to a third-alarm fire which brought Engine 56, and Engine 58 to assist at the fire scene

- On September 14<sup>th</sup> Deerfield units were dispatched to Saddleback for reported structure fire. Ladder 57 and Battalion 56 arrived on scene with a confirm fire in a single-family dwelling. Crews encounter heavy fire conditions on the back side of the house that was extending throughout the residence. The fire resulted in total loss of the structure.

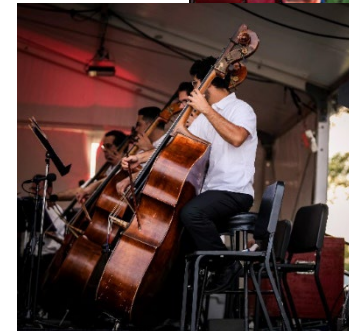

## Deerfield Township, Warren County Foundation and Duke Energy Team Together On NEW Small Business Development Grant Program

Earlier this year, the Warren County Foundation, Duke Energy, MADE Chamber and Deerfield Township joined forces to launch a new small business development initiative. This program provides emerging entrepreneurs and small business owners with funds to help them grow and sustain their businesses. \$1,000 to \$2,000 grants are available to eligible businesses with no more than fifty employees. # Public Works - Road and Bridge

---

*This report highlights the key accomplishments of the Road Department during the third quarter of 2024.*

## **Comprehensive Maintenance:**

- Conducted thorough zone checks in areas 7,8 and 9 for all street signs.
- Repaired potholes and addressed drainage concerns.
- Assisted the cemetery with maintenance needs.
- Maintained township roads through mowing and brush chipping, including trimming trees along walking paths.
- Completed all zoning violation mowing required.
- Repaired 10 catch basins
- New pathway on Irwin Simpson – Trimmed all Vegetation along pathway.

## **Drainage and Road Enhancements:**

- Successfully restored and reshaped ditches/ pipe work - Tulip Tree, Southland Dr. Crestview Dr.
- Completed asphalt work in Foster Park.

## **Community Engagement:**

- Actively participated in two touch a truck events. The Gardner School and the Town Center.
- Successfully assisted with the Cincy Pops concert and several other Township events.

## **Employee Development:**

- Larry Easterly successfully passed his CDL test.

## **Street Lighting:**

- Conducted proactive inspections of Zones 5 through 8, identifying and reporting 7 defective streetlights for repair.

## **Sidewalk Replacement Project:**

- Staff received two bids for this project. R.E. Middleton Construction was awarded at the August 20, 2024, meeting.
- The project is to begin in late October to early November.

## **Street Marking Project:**

- Sealed bids were opened on September 9, 2024. The Aero-Mark Company LLC.
- Project commencement is set for mid-October 2024, with an anticipated completion by November 15, 2024.

## **Hazard Tree Removal:**

- 19 trees were identified for removal to improve safety for residents and the traveling public. A1-Tree Care will begin removing dead, dying, or diseased trees in late October 2024.

## **Kings Mills Improvement Project:**

- Phase III of the ongoing Kings Mills Improvement Project was completed by Barrett Paving in July.
- Phase IV bid opening was held on July 2, 2024. Barrett Paving Materials Inc. was awarded the project. Project commencement is set for mid-August 2024, with an anticipated completion by December 2024.

## **Landscaping Maintenance:**

- Degree Landscaping is continuing the monthly bed inspections.

## **Events and meetings:**

- Public Works Department staff assisted and worked Township events.

## **Streetscape Improvement Project:**

- Finalized bid documents and awarded the 2024 Streetscape Improvement Project to Benchmark Land Management Project commencement is scheduled for early July, with anticipated completion by September 30th.

## **Project Planning and Development:**

- Advanced preparations for the Kings Mills Improvement Project Phase IV, anticipating funds to be available in late July early August.
- Continuing to collaborate with the WCTID on the Irwin Simpson Pathway project and the Kingswood Connection Path.
- Partnered with Kleingers Group to design streetscape improvements and landscaping enhancements along Mason-Montgomery Road and various other locations. Phase I of this project will begin in mid to late July, with Phase II design work is ongoing.
- Preparing all paperwork and meeting with Engineering for the Carter Park Pathway Project

## **Safety and Training:**

- Maintained a strong commitment to safety by conducting monthly training sessions for all service personnel.
- Attending High Performance Leadership Class that started in August and ends in November.





# Deerfield Regional Storm Water District

## **Resident Service:**

- Responded to 40 resident inquiries and 2 requests for assistance (RFAs) related to stormwater issues.

## **Project Management:**

- Successfully completed 6 stormwater projects and advanced an additional 7 through design or construction phases.

## **Infrastructure Improvements:**

- The District recently completed stormwater projects in the Montclair, Afton Falls, and Hampton Village subdivisions. The projects cleared blocked storm sewers, which will reduce localized flooding, and repaired damaged pipes, which allowed root intrusions and sinkholes to form.

## **Planning and Development:**

- The District is exploring the feasibility of drainage studies and evaluations for Seilcrest Acres, Kings Auto Mall, and the Snidercrest and Snider Road areas. If the studies move forward, the results will guide the District's future maintenance and improvements to the stormwater system in these areas.

## Administrative Projects



- Partnered with OSU Extension and Warren County Park District to bring programming such as Wits Workouts and Wellness Walks to the community
- Parks collaborated with Deerfield Towne Center and KimCo for the Touch a Truck event in September which had an estimated 2000 community members in attendance.
- Partnered with Council on Aging to bring the Tai Chi program to Kingswood Activity Center. Both sessions sold out quickly.
- Cincinnati POPS concert and drone show was again a huge success with positive feedback from the community.
- Movies in the Park were held in July and September with good attendance at each. September showing was geared towards teens and adults.
- Fitness in the Parks continues to be a popular way to get community members outdoors and active. These programs are provided free of cost in partnership with Crunch Fitness and Pure Barre Mason.

## Recreation Programs

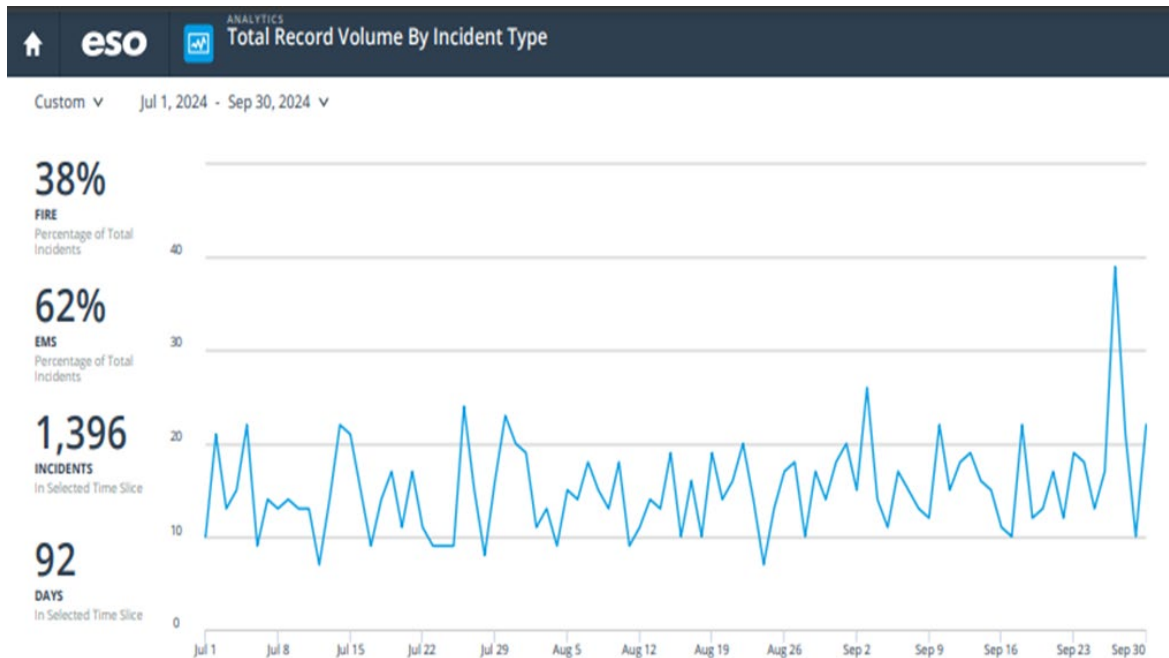
